

For most individuals, the most difficult part of purchasing a home, especially for first time home buyers, is the ability to save the required down payment. Attain Mortgage allows for individuals to borrow the necessary funds to use as their down payment, commonly referred to as Flex Down or Borrowed Down Payment.

Attain Mortgage Flex Down Payment Guidelines

Borrower Qualification	<p>Minimum Beacon Score of 680 for 90.01% - 95% LTV.</p> <p>Reserved for First Time Home Buyers, exceptions may be considered</p> <p>Non-Residing Co-Borrowers are accepted however must be an immediate family member.</p> <p>Existing requirements related to income, down payment and credit worthiness will apply.</p> <ul style="list-style-type: none"> • Maximum GDS & TDS= 39% & 44%
Eligible Transactions	<ul style="list-style-type: none"> • First Time Homebuyers. • Max 2 units where 1 unit must be owner occupied. • New Construction with required Home Builder Warranty Program/Existing re-sale properties. • Purchase Plus Improvements/2nd Homes Type A.
Ineligible Transactions	<ul style="list-style-type: none"> • Business For Self Alt A • New To Canada • Rental Properties • Refinance
Terms / Qualifying Rates	<ul style="list-style-type: none"> • Fixed Terms: 1, 2, 3, 4, 5, 7, 10 year • Variable Terms: 3 and 5 year • Loans (fixed rate and variable rate products) are qualified on the greater of the contract rate or the 5 year Benchmark rate.
Insurance Premium	<p>90.01% - 95 % LTV</p> <p>Premium of 4.50%</p>
